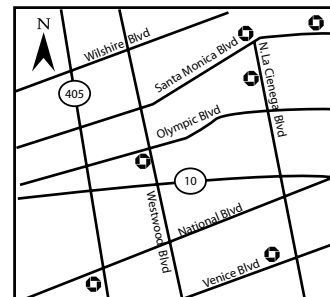

1. **Voting Terms and Conditions:** To cast a vote for your favorite participating charity, visit one of the following Chase branches at 8951 Santa Monica Blvd., 7073 Santa Monica Blvd., 2201 Westwood Blvd., 11700 National Blvd., 8985 Venice Blvd., or 100 N. La Cienega Blvd., between 10/8/11–11/19/11, during regular banking hours and meet with a Chase representative. No bank transaction is required. Limit: One (1) vote per person, per week. Must be 18 years of age or older and a resident of California to participate. Chase employees are excluded from voting. Void where prohibited. No proxy votes permitted. Identification may be requested. Winning organization is determined by verified votes cast. Ties will be resolved by agreed-upon terms between Chase and the participating organizations. All votes will be verified and counted by an independent judging organization.
