Reading to Kids is a grassroots organization dedicated to inspiring underserved children with a love of reading, thereby enriching their lives and opportunities for future success. To this end, Reading to Kids organizes monthly reading clubs on the second Saturday of every month at Los Angeles area elementary schools. During the COVID-19 pandemic, the monthly reading clubs have continued, but via Zoom with the assistance of the teachers at our partner elementary schools.

Reading Encouragement Programs: Reading to Kids organizes reading clubs at eight Los Angeles area elementary schools on the second Saturday of each month. Before the COVID-19 pandemic, approximately 30 teachers, 100 parents, 300 volunteers, and 600 children would attend our monthly reading clubs. Beginning in May 2020, the reading clubs went virtual via Zoom, with an average of 22 teachers, 66 volunteers, and 177 children attending the monthly reading clubs during the last fiscal year. During the reading clubs, pairs of volunteers read teacher-selected books to small groups of children while their parents attend teacher-led classes, receiving training on how to encourage their children to read at home. The 90-minute reading clubs end with an arts and crafts project for the children, which is designed to further inspire them with a love of reading. The books used at the reading clubs are donated to the school libraries, and the attending children and parents receive prize books to take home to supplement their home libraries. Attending teachers also receive prize books for their classrooms in thanks for their assistance with the reading clubs. During the virtual reading clubs, the parent classes have been suspended until we resume in-person reading clubs.

Form 990, Part I, Line 6 - Prior to the COVID-19 pandemic, Reading to Kids utilized over 1,500 volunteers per year at our monthly reading clubs. Because the reading clubs have been conducted virtually since the beginning of the pandemic, Reading to Kids has exclusively relied on a set of experienced volunteers to conduct the reading clubs. Reading to Kids expects to return to a greater number of volunteers once we are able to resume in-person reading clubs.

Form 990, Part III, Line 3 - Beginning in May 2020, in light of the COVID-19 pandemic, the monthly reading clubs went virtual via Zoom. The format of the reading clubs remained the same with pairs of volunteers reading to groups of children at eight Los Angeles area elementary schools. But rather than reading to the children in person, inside classrooms at the elementary schools, the reading clubs took place virtually, using the Zoom accounts of teachers at the participating schools. The teachers who hosted those reading clubs invited their students to attend and welcomed Reading to Kids volunteers to join them for the reading clubs.

Form 990, Part VI, Section B, Line 11b - The Form 990 was prepared by the Reading to Kids Treasurer based on the information contained in the organization's financial statements, which were previously reviewed and approved by the Board of Directors. Prior to the filing of the Form 990, a PDF copy of the Form 990 was emailed to all Board Members for the review and approval of the Board.

Form 990, Part VI, Section B, Line 12c - Reading to Kids annually requires its officers, board members, and employees to sign a conflict of interest disclosure form. If a conflict is identified, the person with the conflict (i) must fully disclose the conflict to all other decision-makers; and (ii) may not be involved in the decision of what action to take (e.g., may not participate in a vote) but may serve as a resource to provide other decisionmakers with needed information. In some cases the person with the conflict may be asked to recuse him/herself from sensitive discussions so as not to unduly influence the discussion of the conflict. In all cases, decisions involving a conflict will be made only by disinterested persons.

Form 990, Part VI, Section B, Line 15 - Salaries of all Reading to Kids employees are determined by the independent Board of Directors through regular reviews of the work of the employees and by comparison to similarly situated employees in the nonprofit sector. Salary reviews are discussed and documented during executive sessions of Reading to Kids board meetings.
